- 5. We have a family that wants to buy the one pool bond that we have for sale. Sara will start the process with the family.
- 6. Community Pass- Sara did a demo to test it and loved it. Members can have a membership card and have it on their phones to scan as they enter the pool so that we can keep track of attendance in real time. Events can be tracked through the site and members can pay to attend events on their website. Need to check what their fees are to make sure it's worth changing.

# **Building and Grounds:**

- 1. Does Ace need the water on by a certain date? Must be on before April 15th
  - a. Remove any items from bathhouse, clear debris, etc.
- 2. Eric is meeting with Countryside Lawn Service tomorrow to look at the area behind the pumphouse and he's also going to ask about the sand on the volleyball court. Can also ask for an estimate for weeding a few times over the summer.
- 3. Possibly some holly bushes for hedgerows to provide some plant cover
- 4. Countryside has a fire pit package. Need to look at the impact to our insurance. Will want a gas fire pit.
- 5. Ordered 5 umbrellas and 5 stands- all 9'
- 6. Ordered soap dispensers that do not run on batteries
- 7. Extra camera that points towards the pool- \$40-\$50 for the camera. We have an unlimited plan and can have as many cameras as we want. All clips are automatically sent to an external drive and saved.
- 8. Discussion to create a Buildings and Grounds Amazon account with our pool credit card linked to it. Fran will talk to Lori to set this up.
- 9. Estimate for fixing the fence from the corner at the entrance to the volleyball court and a new gate- Fran will follow up to get estimates. Should be the same color and height as the one in the parking lot.
- 10. Fran ordered "This premises monitored by security cameras" signs.
- 11. Changing room cabanas that can be mounted to the concrete or the fence- maybe buy 2 and put them next to the bathrooms.
- 12. Fran will do a supply inventory at the end of March
- 13. Chaise lounges are \$271 each. Fran will email everyone to confirm price for a few more chaise lounges and the small tables.
- 14. Eric will talk to Countryside Lawn Service about prepping the retaining wall to be able to paint.
